Limitations of Use

- Usage, maintenance and storage as per manufacturer's instructions.
- The fabric was not tested for Resistance to penetration by liquids against o-Xylene and Butan-1-ol (as required in 4.12 of EN 13034:2005). It does, however, pass the permeation requirements of EN 14605:2006 (Class 6) which is a more challenging test and can therefore be assumed to pass for these chemicals.
- The garments listed above meet the requirements of EN 1149-1:2006 and EN 1149-5:2008 for electrostatic dissipative protective clothing, however they may not be suitable for use in explosive atmospheres, as indicated by the manufacturer's user information.
- The Lakeland Gloves attached to some coverall styles are separately certified and are not covered by this EC Type-Examination Certificate.
- The User Information has been assessed in the English language only. It is the responsibility of the Manufacturer / Authorised Representative to ensure the content and accuracy of the User Information presented in other languages.
