The earplug hearing protector must be properly worn to provide effective protection. Follow these instructions and contact supplier.

Loud noise in the workplace can be very damaging to hearing and it usually happens gradually, so that employees are not aware of the dangers until they have already developed permanent hearing loss. As well as gradual hearing loss, there is also hearing loss that results from sudden and extremely loud noises. These ear plugs help reduce exposure to hazardous noise and other loud sounds.

FITTING INSTRUCTIONS

1. Roll into a small crease free cylinder.
2. Insert into the ear canal and hold until plug expands.
3. Remove the earplug slowly and with a twisting motion to gradually break the seal.
4. Check proper fit before enter into noisy environment.

3. The earplugs are disposable.
4. Store in a cool and dry place, away from direct sunlight, recommended shelf life is 3 years. Manufacture date can be known from the lot number indicated in this user information, such as mm/yyyy. (Month/Year)
5. After using, the earplugs should be disposed of away from children.
6. Transport the earplugs with the original packaging.

WARNING

2. Keep earplugs away from small children (risk of inhalation and suffocation).

LIMITATION

The single noise rating (SNR) quoted is based upon the attenuation of continuous noise and these ear-plugs may not suitable to be used as followings:

- use in intermittent or impulsive noise environment where need high level of sound attenuation.
- use in the environment that require additional attenuation especially in low frequencies dominated high noise environment.
